The (COSHH) Control of Substances Hazardous to Health Regulations may apply to the use of this product at work.

OPERATOR PROTECTION

Engineering control of operator exposure must be used where reasonably practicable, in addition to the following personal protective equipment: **WEAR SUITABLE PROTECTIVE CLOTHING (COVERALLS), SUITABLE PROTECTIVE GLOVES AND FACE PROTECTION (FACESHIELD)** when handling the concentrate. However engineering controls may replace personal protective equipment if a COSHH assessment shows that they provide an equal or higher standard of protection. **AVOID CONTACT WITH SKIN AND EYES.**

DIRECTIONS FOR USE

Tank & Equipment Cleaner is ideal for cleaning the inside and outside of sprayers including residues of pendimethalin and trifluralin with some mechanical assistance.

For sulfonylurea herbicides the approved de-contaminant should be used. However, to ensure oily contaminated deposits are removed initially clean with T&E Cleaner then with the recommended de-contaminant.

T&E Cleaner will remove rust or hard water scale from surfaces and leaves a protective film to minimise corrosion during winter storage.

COMPATIBILITY

Tank & Equipment Cleaner **must not** be mixed with any bleach based cleaner.

RATE OF USE

Routine cleaning rate 500 grammes in 500 litres

Stubborn stains rate 30 grammes in 10 litres

MIXING

Flush out sprayer with clean water.

Half fill spray tank.

Slowly add Tank & Equipment Cleaner.

Top up tank and agitate thoroughly.

Open booms and spray out. With persistent chemicals/end of season storage, allow the mixture to stand overnight before emptying.

Then flush out with clean water. If the sprayer is to be stored, do not flush out with clean water until just prior to re-use since Tank & Equipment Cleaner will leave a protective film.

DISPOSAL OF SPRAY TANK WASHINGS

Under disposal of spray washings regulations, washings may be applied to the crop which has just been sprayed, provided that this does not exceed the maximum applied dose for that crop. Because T&E Cleaner is very effective, when used correctly it will remove/dislodge agrochemical residues "held" in the sprayer systems. These may be inappropriate for the crop just sprayed in terms of application timing, phytotoxicity or approval for use on that crop, unless the sprayer is cleaned between each crop type i.e. sugar beet and cereals.

In view of this we recommend:-

- Start with a T&E cleaned sprayer.
- After each use clean out with T&E Cleaner. The spray washings can be safely applied to the crop just sprayed provided that the dose does not exceed total approved dose for the crop.
- The maximum safe concentration for application to the crop is 0.1% w/v of Tank & Equipment Cleaner i.e. 1 kg Tank & Equipment Cleaner in 1,000 litres of tank washings.
