## **SAFETY INFORMATION**

## Warning

## **FORMULATION**

A soluble concentrate formulation containing a proprietary blend of water conditioning agents, acidifying agents, pH buffers and an anti-foam.

#### **RATES OF USE**

X-Change is recommended for use up to a maximum concentration of 0.25% dilution of the final water volume example:-

Water Volume	Required Quantity of X-Change 0.25%
100 litres/ha	250 ml
200 litres/ha	500 ml

#### **MIXING**

X-Change must be added before the pesticide.

- 1. Half-fill spray tank and begin agitation.
- Add the correct quantity of X-Change for the final water volume.
- 3. Continue filling the spray tank to the required volume, adding the pesticide(s) as directed.

## **DIRECTIONS FOR USE**

X-Change can be used with all pesticide sprays on all crops, at all timings, where water conditioning or pH adjustment is required.

X-Change is recommended with e.g. the following products/product groups:-

- All approved formulations of glyphosate.
- All approved uses of 'dim' and 'SU' herbicides.
- All approved uses of organophosphorus insecticides and pyrethroids.
- Salt formulations of phenoxy acid herbicides.
- Regalis and Canopy (follow the BASF recommendations).
- Atlantis WG and Pacifica (follow the Bayer recommendations).
